This correspondence will serve as the official notification by the Nominating Committee that the offices of **3rd Vice President, Secretary, and Treasurer** will be filled at the Louisiana PTA State Convention in April 2012.

The Nominating Committee invites recommendations from any member of the Louisiana PTA for the aforementioned offices. The postmarked deadline for receiving such recommendation is February 1, 2012.

The requirements for these officers are indicated below. (Please refer to Article VIII, Section 3 of the State Bylaws).

### Section 3 – Qualifications for nominating shall be:

The following provisions shall govern the qualifications and eligibility of individuals to be officers of the Louisiana PTA:

- a. Each officer shall be a member of a local PTA chartered by the Louisiana PTA.
- b. President shall only serve for one term.
- c. First vice president, second vice president, third vice president, secretary, and treasurer may be eligible to serve no more than two succeeding terms in the same office.
- d. A nominee for president shall have served on the board of directors for at least two (2) years and have been a unit or district president.
- e. A nominee for first vice president, second vice president, third vice president, secretary and treasurer shall have served on the board of directors or on a district board.
- f. A person who has served in an office for more than one-half of a full term shall be deemed to have served a full term in such office.
